Mary Wolff was my first boss and mentor in public health as a premedical student. Phil Landrigan had made the introduction: When he recruited me to Mount Sinai's Children's Environmental Health Center out of a Bronx, NY public school classroom, he didn't have any job openings, but referred me to Mary, who then needed an assistant. She was maybe the best woman working in environmental health today, he said, and knowing nothing about her, I

Googled her biosketch. Immediately I was daunted by her accomplishments: a Yale PhD (I think before women could attend as undergrads), seminal environmental epidemiology research as a postdoc for Irving Selikoff, then her myriad investigations with Phil. When I first met her in her office, I was shocked by this prolific scientist's Zen nature. She nursed plants in the window, recommended the best chocolates in the West Village, and explained how she maintained her neti pots around her many, many heaps of neatly annotated papers. Though my role on her team was mostly administrative, she taught me about everything I know about scientific writing, ethics, and integrity, and that was on top of her expertise on the science of endocrine disruptors. Everything she did was so precise, yet seemed so easy, and I was in awe of it half of the time. (The other half, she told me to chill, and she was right.) Mary has over time built a powerhouse roster of women scientists there around her, and she basically sold me on NYU School of Medicine based on her daughter's experiences of practice there. Though our research interests diverged, and I haven't seen her often in recent years, I consider her my first and greatest mentor in epidemiology. Her choice to hire me helped change my life, on top of the many lives she has likely saved through her science.

Also, kudos to Xinye Qiu, Mahdieh Danesh-Yazdi, Yaguang Wei, Qian Di, Allan Just, Antonella Zanobetti, Marc Weisskopf, Francesca Dominici, and Joel Schwartz for their paper entitled "Associations of short-term exposure to air pollution and increased ambient temperature with psychiatric hospital admissions in older adults in the USA: a case—crossover study" that was just been published in The Lancet Planetary Health. They found that in the US Medicare population, short-term exposure to elevated concentrations of PM_{2·5}, NO₂ and cold season ambient temperature increase were significantly associated with an

increased risk of hospital admissions for psychiatric disorders (including depression, schizophrenia, and bipolar disorders). Considering the increasing burden of psychiatric disorders in the US population, these findings suggest that intervening on air pollution and ambient temperature levels through stricter environmental regulations or climate mitigation could help ease the psychiatric healthcare burden.
