



Faculty Spotlight

Dr. Natalie Slopen joined the SBS Department in January 2021 as an Assistant Professor. Previously a faculty member at the University of Maryland School of Public Health, she received her ScD in Social Epidemiology at Harvard Chan and her postdoctoral fellowship training at the Center on the Developing Child at Harvard University. Dr. Slopen's research primarily focuses on the early life origins of health and health disparities, and her studies aim to identify modifiable risk and protective factors that can be targeted by interventions.

"I first got involved in research during my undergraduate training in psychology. From this introduction, I learned that I loved research and slowly found my way to public health. During my doctoral training I focused on psychiatric epidemiology, and as I became increasingly aware of the

strong connections between mental and physical health my research interests broadened.

My research spans two general areas. The first domain focuses on how early life experiences and environments become embedded to influence physical and mental health over the life course. My second research area focuses on social and contextual influences on common chronic disease and psychiatric health outcomes among adults, such as affective disorders and cardiovascular disease risk factors and outcomes, including sleep."

Alumni Corner

Michelle Lugalia-Hollon, SM' 10 advises students to seek mentorship and advice from leaders in the field that are doing the work you would like to do. In an update, she shares her recent experience as the Director of Policy for the Mayor of San Antonio.



"I started working for the Mayor of San Antonio as his Director of Policy in July. 4 months into the pandemic, the city was upended. Our responsive strategies had to prioritize the immediate needs of our residents -- testing, rental assistance, the digital divide -- while addressing the long-standing inequities that the pandemic exacerbated.

One of my first tasks was to facilitate the development of a workforce program that would spur economic mobility and end generational poverty. San Antonio has been known for its low-

wage jobs, a service industry and tourism dependent economy and too many adults with less than a college or high school degree. This has led to high poverty, economic segregation and racial disparities. Many of our recently unemployed and low-income residents had incomplete or no college degrees and worked in unstable, low-paying jobs.

So together with key stakeholders, we drafted a policy to avail free training in certificates/degrees that prepare residents for in-demand and high wage jobs, including funds to address barriers that prohibit program completion. In November, we put the initiative on the ballot asking voters to allocate \$154M in sales taxes to support the 4-year effort. They resoundingly chose to invest in themselves and their neighbors."

Awards and Honors

A manuscript published in 2020 by **Stephanie Child** and her colleagues, titled "Socioeconomic Differences in Access to Neighborhood and Network Social Capital and Associations with Body Mass Index among Black Americans" has been selected as an **Editors' Picks Papers of the Year for 2020** in the American Journal of Health Promotion.

Ichiro Kawachi, Karestan Koenen, SV Subramanian, and David Williams have been recognized as one of the Highly Cited Researchers in 2020 according to the Web of Science.

Nancy Krieger has been named the 2020 recipient of the American College of Epidemiology's Outstanding Contributions to Epidemiology Award. The award recognizes an active epidemiologist for outstanding contributions to the field in one of three areas: 1) methods development; 2) etiologic research; or 3) applied epidemiology, and she was given the award "in recognition of her exemplary work in the field." Krieger received the award on December 1, 2020 and will deliver a platform talk at the College's 2021 annual meeting.
